FCPS will accept negative results from COVID-19 Home Test Kits for symptomatic individuals seeking to return to school.

Please follow all testing instructions provided by the kit manufacturer and located inside the test box. After testing your child, please follow the instructions below and fill out the **COVID-19 Home Test Results Form** completely.

If Test #1 is POSITIVE (your child has COVID-19):

- Your child MUST stay home for at least 5 days from the onset of COVID-19 symptoms.
- Your child may return to school on day 6 as long as their symptoms have improved AND they have had no fever for at least 24 hours without the use of fever-reducing medicine AND are able to consistently and appropriately wear a face mask. Otherwise, your child will need to stay home for at least 10 full days.
- You do not need to test your child a second time if the results were positive. You may keep the extra test for use as needed for yourself or others.

If Test #1 is NEGATIVE:

 You must perform a second test <u>between 24 and 48 hours</u> after completion of the first test, and fill out the COVID-19 Home Test Form for Test #2 completely.

If Test #2 is NEGATIVE (No sooner than 24 hours after completion of Test #1):

- Your child most likely does not have COVID-19.
- Your child may return to school as long as they have had no fever for at least 24 hours without using fever reducing medicine.
- For your child to return to school, a parent/guardian MUST sign and submit the completed COVID-19 Home Test Form for both tests to the front office or school health room.

If Test # 2 is POSITIVE:

- Your child MUST stay home for at least 5 days from the onset of COVID-19 symptoms.
- Your child may return to school on day 6 as long as their symptoms have improved AND they have had no fever for at least 24 hours without the use of fever-reducing medicine AND are able to consistently and appropriately wear a face mask. Otherwise, your child will need to stay home for at least 10 full days.
